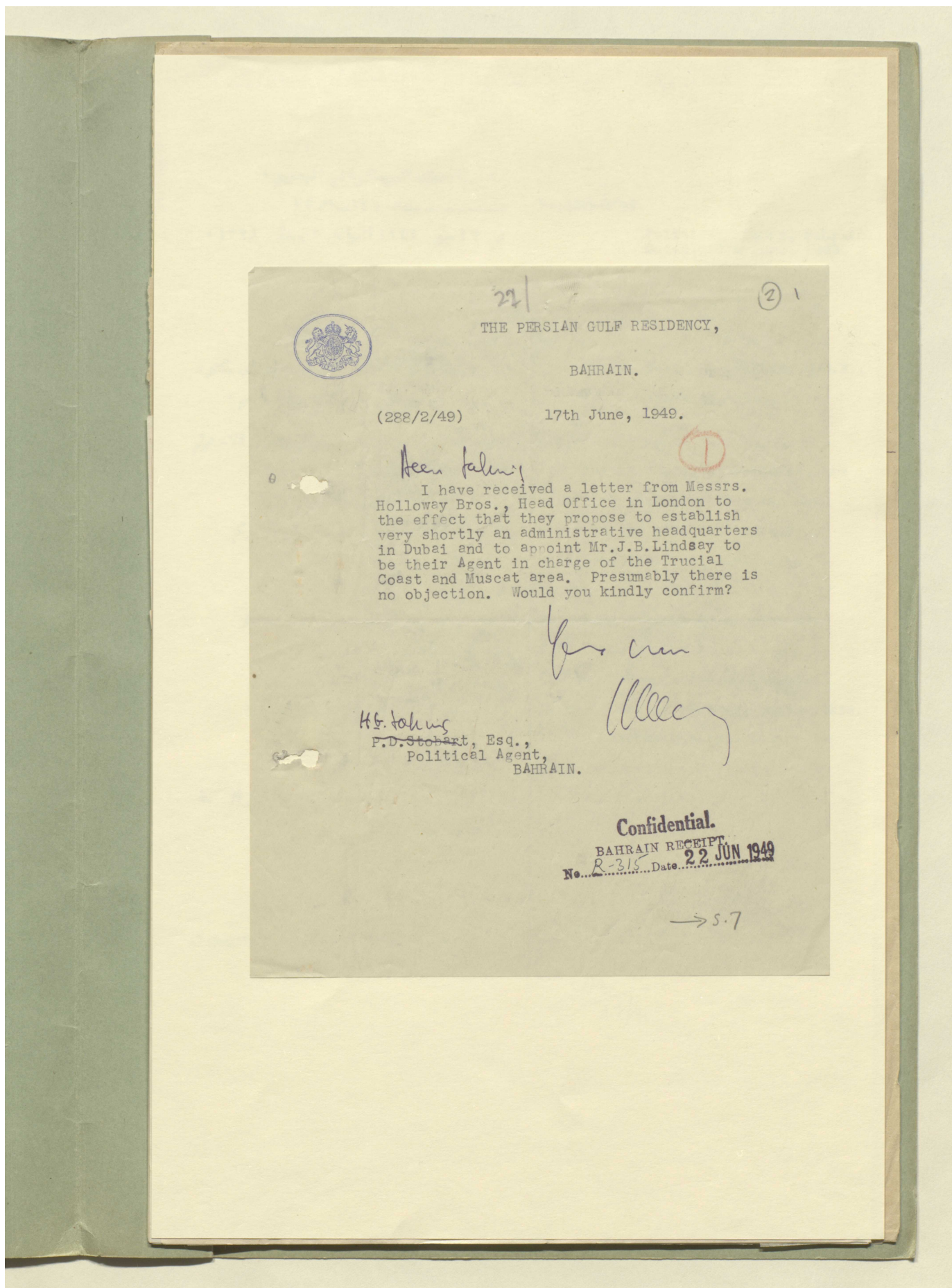

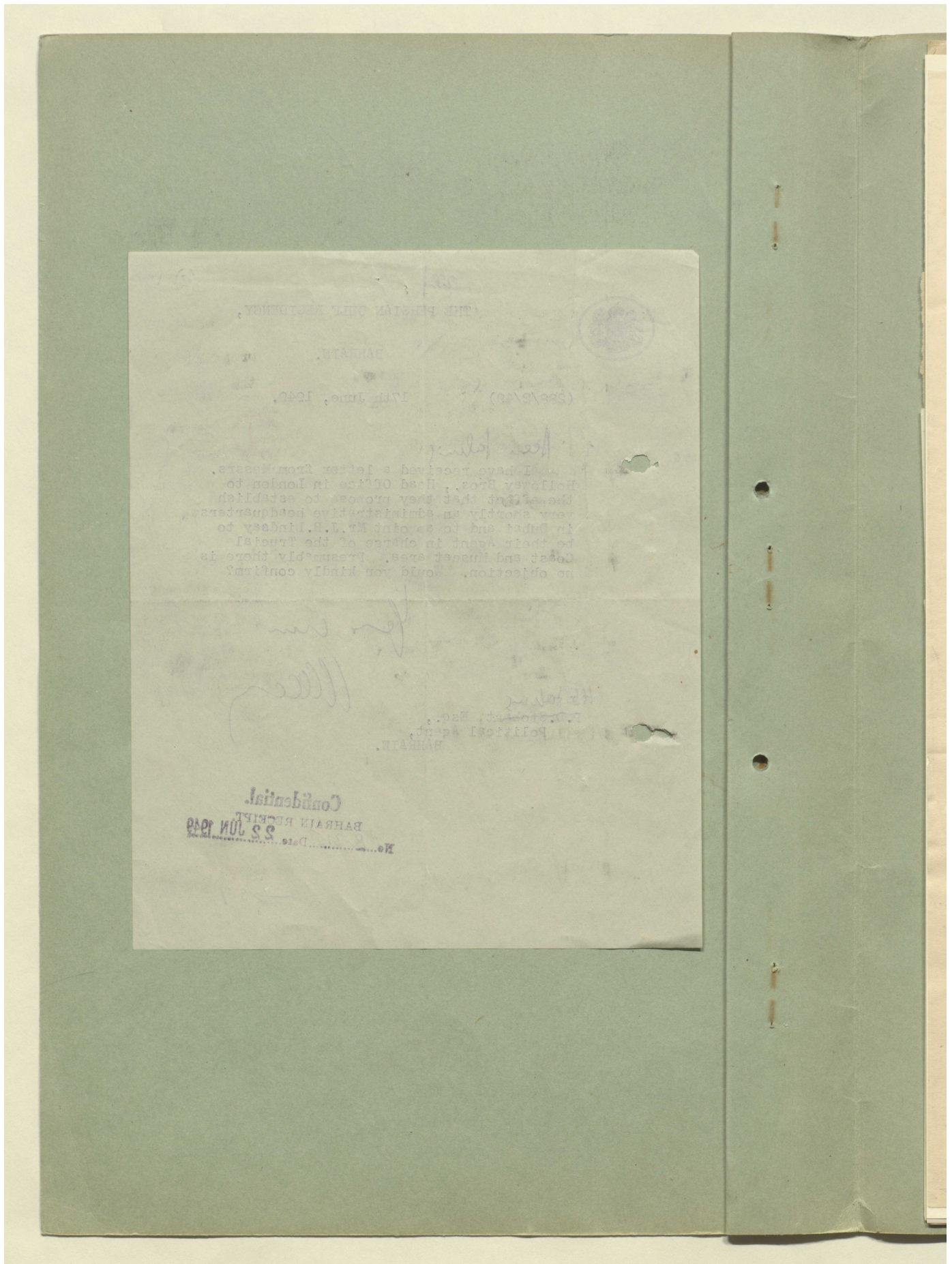

We understood what you have referred to, but it is not possible to give you an answer at present. Our wish is that you postpone this matter till some other time.

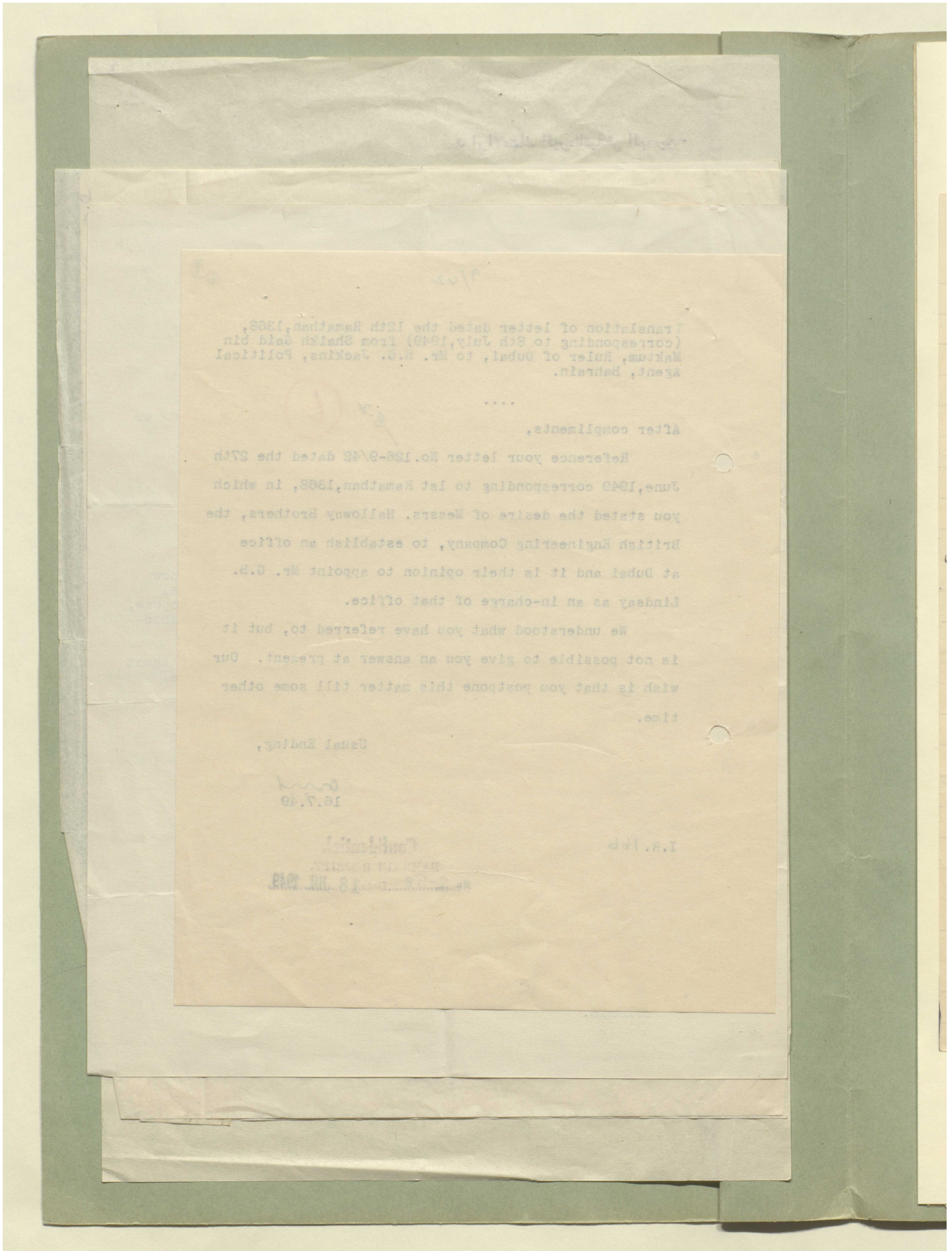

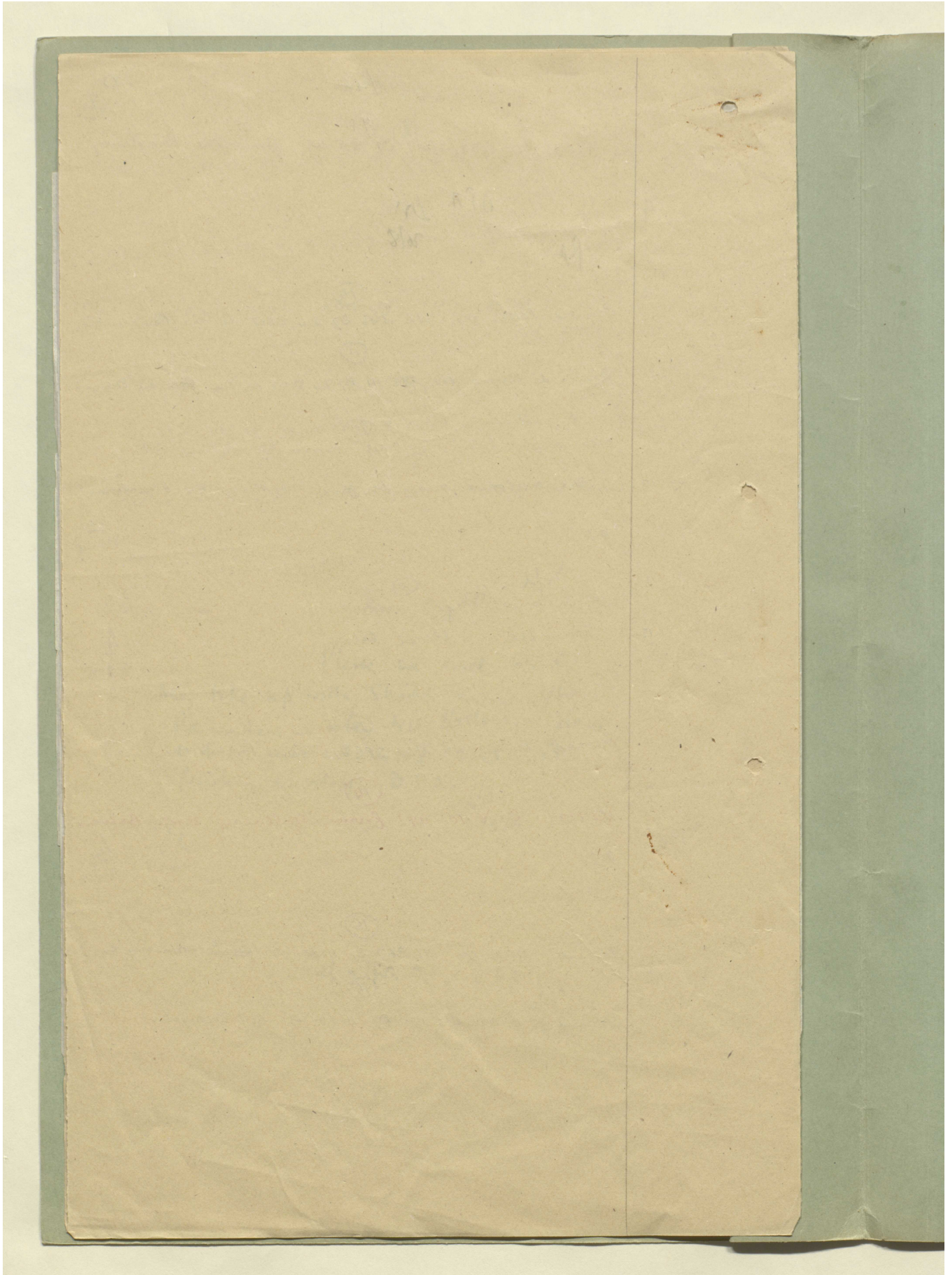

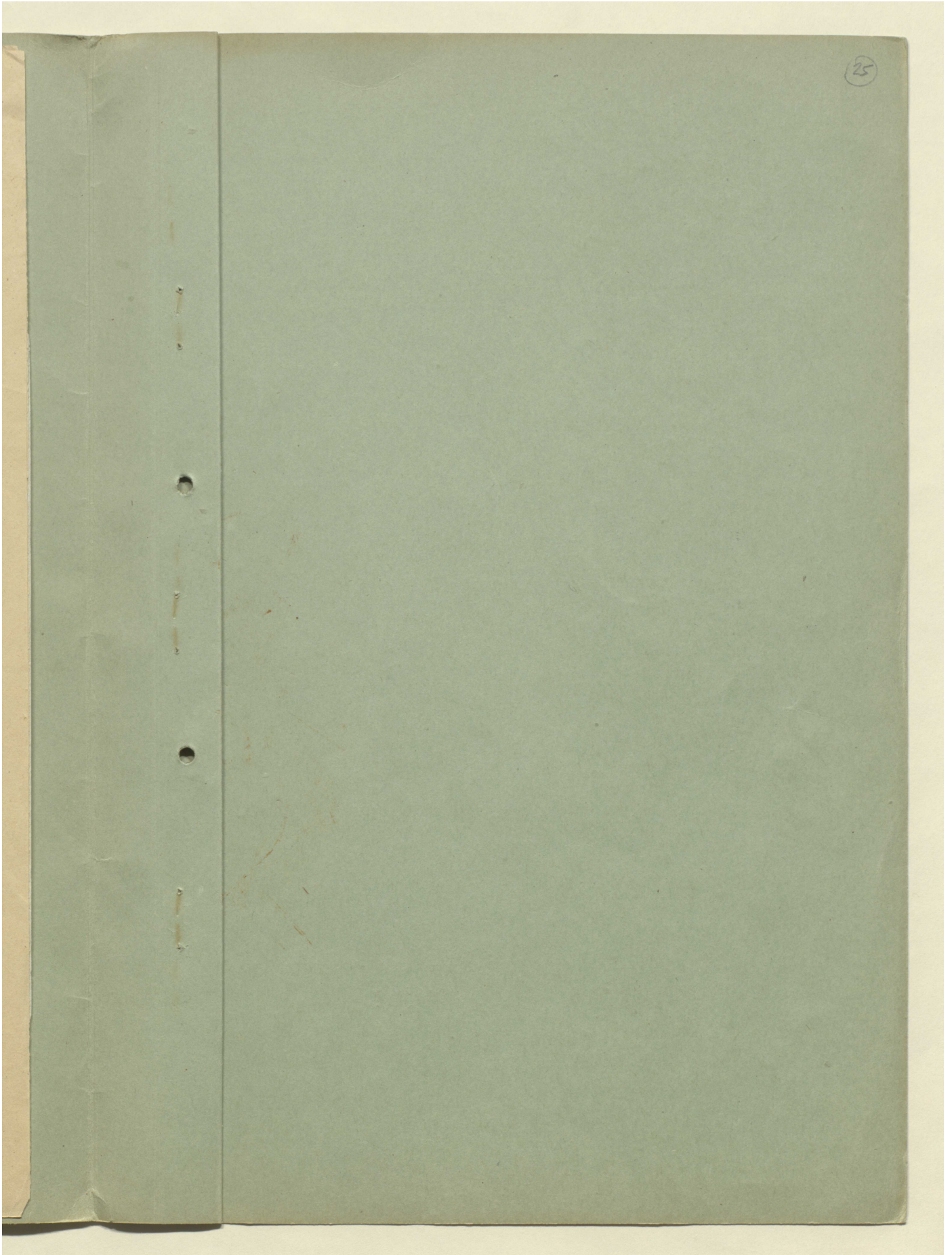
