Bahrain Oil Company's cables to New York fall into three classes

(a) In Clair transmitted through Cable and Wireless. Geneorship at Bahrain ensures that information of potential use to the enemy is not included in this class.

(b) Security cables, containing information which is not in itself secret but which in conjunction with other information might be useful to the enemy

(c) Secret cables, containing matter of direct use to the enemy.

(b) and (c) have hitherto been transmitted either through the Maval authorities or the Political Agency.

2. Company find that censorship on (a) greatly restricts scope of references which they can make to New York and request permission to exchange telegrams with New York in secret Company code with transposition gypher superimposed for security. It is understood that if permission is accorded for transmission of such messages from Bahrain the United States authorities would agree to their reception at destination. Messages concenned deal mainly with technical oil matters, which cannot conveniently be transmitted in Service codes. Company would continue to transmit messages falling in class (c) through Naval authorities or, occasionally, if political matters


