Sir,

I enclose herein a bill for Rs.52/4 for material supplied to Mr.E.R.D'Souza, by Messrs Rochiram Wadhmal, Abadan, on my standing responsibility for the payment.

I have the honour to report now that Mr.D'Souza left the services of the A.+O.C. and has joined Messers at Bahrain. I wrote to him several letters regarding this bill to which he has made no replied, and as Rochiram is after me to get the settlement I beg to place before you this question with a view to obtaining the amount through the Bahrain Consulate.

I have would have paid this bill but unfortunately at the momnet I am very much hardressed owing to my brother's illness and the heavy expenses I had to meet taking him to India when he was medically repatriated two months ago. Mr. D'Souza recognises this bill ,but I am unable to say why he does not make an attempt to settle same or at least to reply to my letters.
