

حول هذا السجل

يحتوي الملف على نسخ مطبوعة من نشرة إضافات وتصحيحات للشخصيات الهامة في مقاطعة الحدود الشمالية الغربية التي تصدر مرتين كل سنة، وذلك عن السنوات من ١٩٣٤ حتى ١٩٣٧. تُعد هذه المجموعة من السير الذاتية إحدى النشرات العديدة السرية وذات الطابع السري الصادرة عن الاستخبارات الهندية، والتي كانت متوفرة للضباط والموظفين العاملين. وهي تقدم معلومات حول هوية ونشاطات وجهات اتصال السكان البارزين والقبائل التي تعيش في الأقاليم العديدة من مقاطعة الحدود الشمالية الغربية من الهند البريطانية [مقاطعة خيبر بختونخوا، باكستان]. مرفق بالملف عديد قليل من المراسلات في سنة ١٩٣٤ بين مسؤولي مكتب الهند في لندن ووزارة الطيران في لندن، بخصوص طلب الأخيرة الحصول على نسخ من نشرة "الشخصيات الهامة" وجميع التعديلات المستقبلية.

W. W. 122-A.—Mirbat, Subedar, son of Salam, Alikhonai Khushali Tori Khel.—One of the most loyal Khassadar Company Commanders who had to be dismissed in pursuance of the Tori Khel blockade in 1937. Was of great assistance to the Faqir of Ipi (W. W. 132-A) in his hostilities against Government. Made peace with Government in 1938 and is again a faithful servant.

W. W. 132-A.—Mirzali Khan, Haji, known as the Faqir of Ipi. Son of Arsalah Khan, Maddi Khel Tori Khel of Ipi village.—Till 1936 a very ordinary mullah who was not known outside his village. By preaching "Jihad" and making extensive capital out of the Islam Bibi case he raised a formidable *lashkar* in the Khaisora Valley in 1936. Its dispersal necessitated military operations on a large scale from November 1936 to January 1937. He then moved to the Shaktu where again large scale operations were undertaken in April 1937. Continued to give trouble throughout 1937 and early in 1938 his party started the planting of bombs on Government roads and other places of common use. Fanatical and openly hostile towards Government. Is regarded as a Saint Warrior, is much respected by all tribes of Waziristan and neighbouring Afghan tribes, and has considerable influence among them. Nearly all the tribes of Waziristan and Afghan tribes of adjoining country took part in his hostilities against Government.

The hereditary chief of the Swathis and the assignee of the revenues of the whole of the valley of Konsh and a portion of the Kunhar Valley. His Jagir amounts to about Rs. 16,042 per annum. Also owns the two large estates of Rajdhwari and Nilishang in the Nandihar Valley (T. T.)
- 305 . . . Zaman Shah—Pir—of Data, son of Saiyid Habibullah Shah, a leading lawyer, President of the Mansehra Bar Association, District Durbari and also President of the Ahmadiya Association of Hazara District.
- 278-A. . . Shahzaman Khan of Sandasar. A retired Honorary Captain, Sardar Bahadur and O. B. E.
- 151-A. . . Kesho Ram, son of late R. S. Jai Ram Shah of Mansehra Is a big landlord and chair-holder.
- 218-A. . . Muhammad Nawaz Khan, son of Muhammad Feroz Khan. A graduate of Government College.
- 298-A. . . Tirath Ram Shah, grandson of late R. B. Jai Ram Shah. Is an Inam Khor and a member of the District Board, Hazara. Title of Rai Sahib has recently been conferred upon him.


