### حول هذا السجل

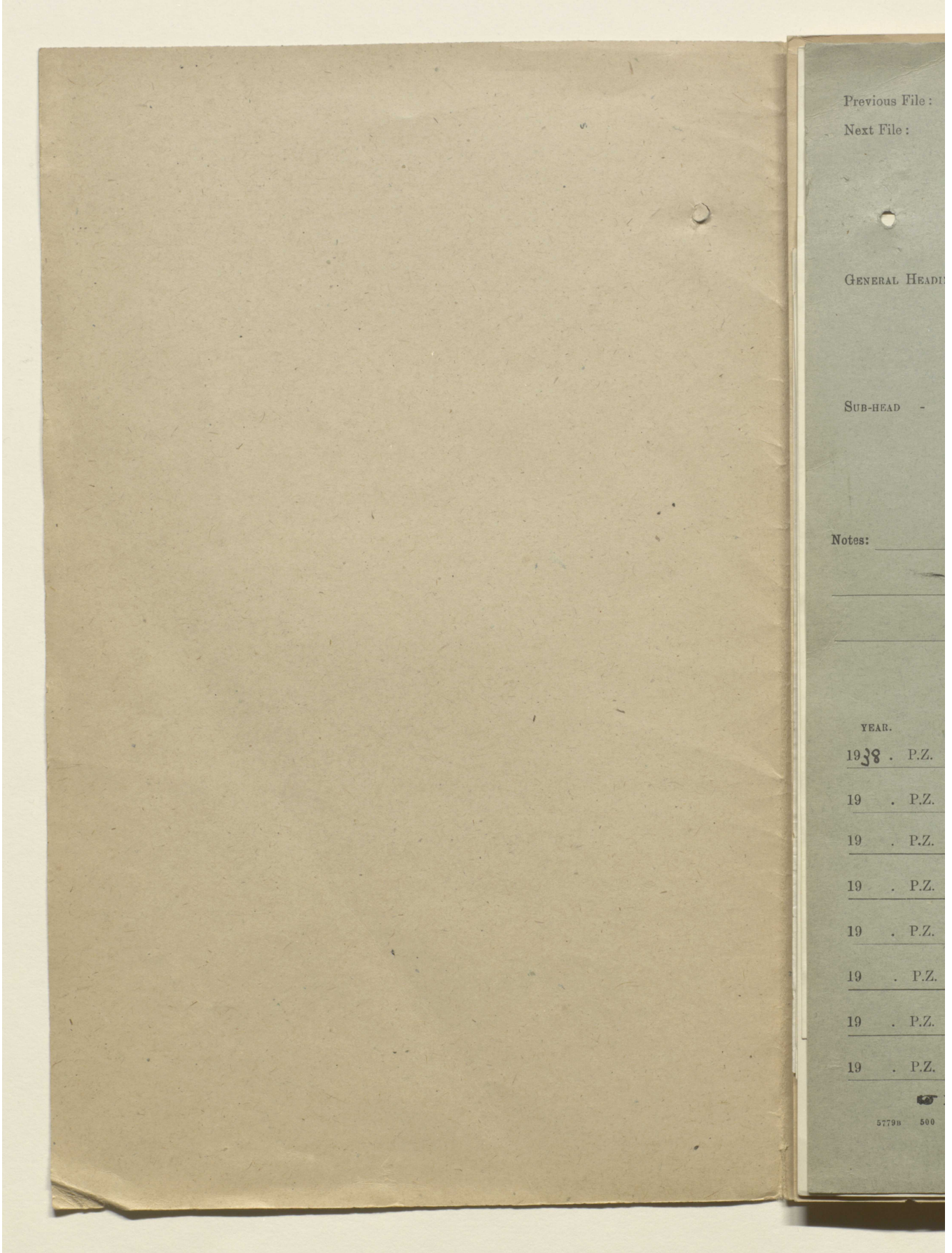

Dear Mr Symon,

I have been favoured with your address by the Department of Overseas Trade and I now take the liberty to ask you kindly for an appointment at some time suitable to you.

I wish first of all to express my sincere thanks for whatever help you may see your way to grant me in my quest for positive information concerning the coinage of Muscat and Oman and, if possible of a few amongst the Indian Native States. I am now engaged in working out a book, or rather a catalogue of coins covering the period 1789 to 1869 and in trying to make as complete as possible a supplement to my book "Coins of the Modern World 1870 - 1936".

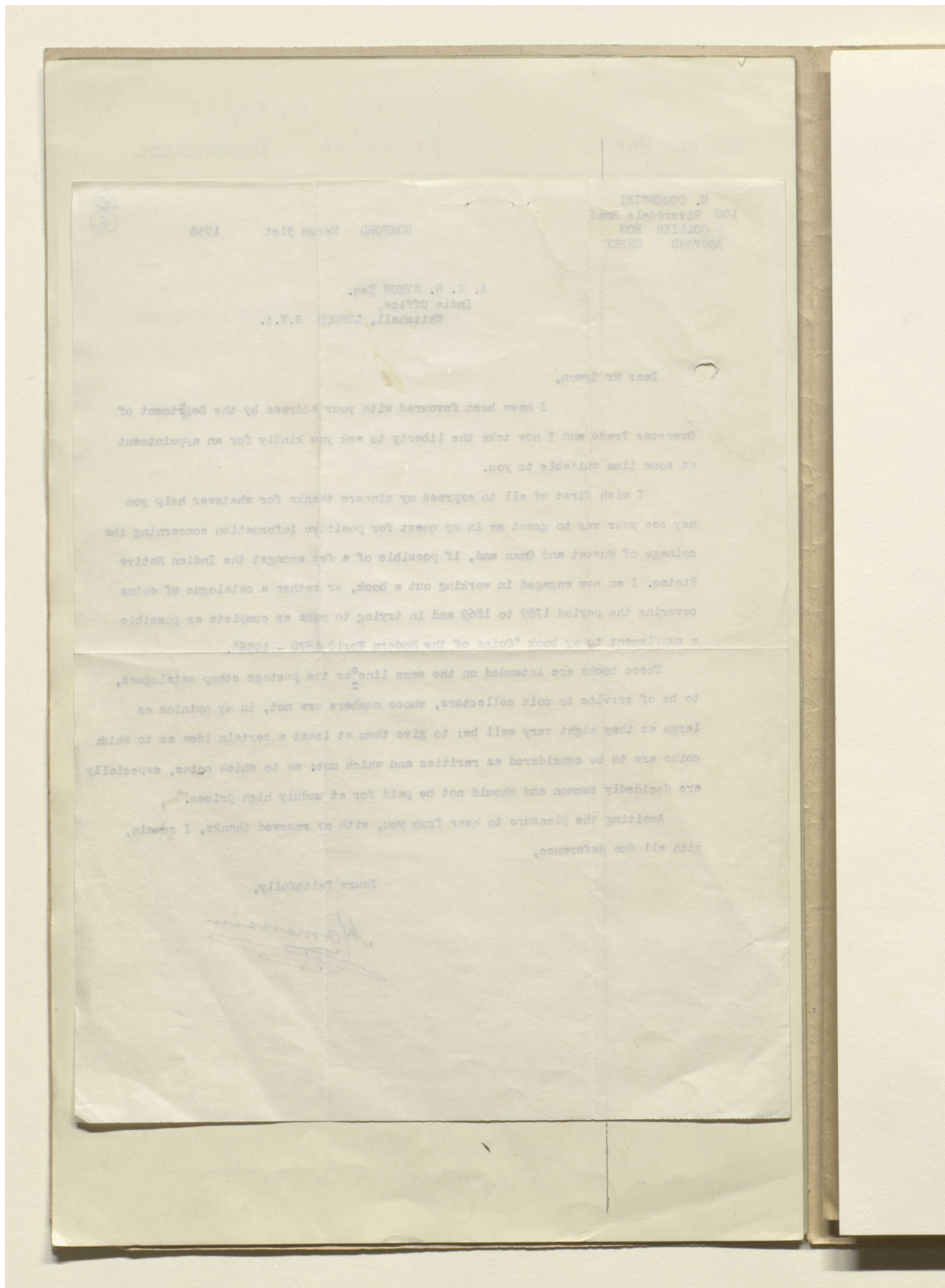
These books are intended on the same line<sup>s</sup> as the postage stamp catalogues, to be of service to coin collectors, whose numbers are not, in my opinion as large as they might very well be; to give them at least a certain idea as to which coins are to be considered as rarities and which not; as to which coins, especially are decidedly common and should not be paid for at unduly high prices.

Awaiting the pleasure to hear from you, with my renewed thanks, I remain, with all due deference,

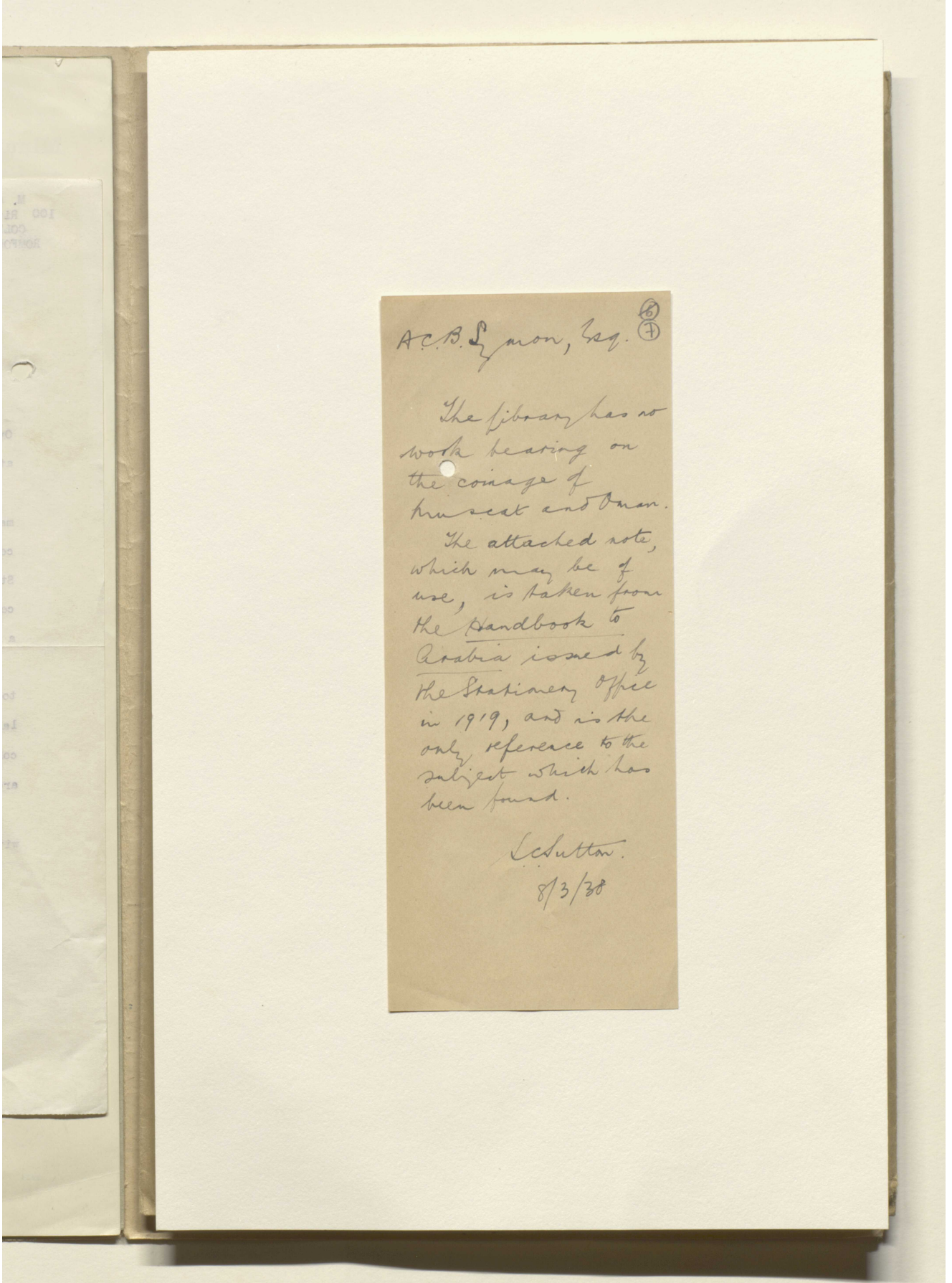

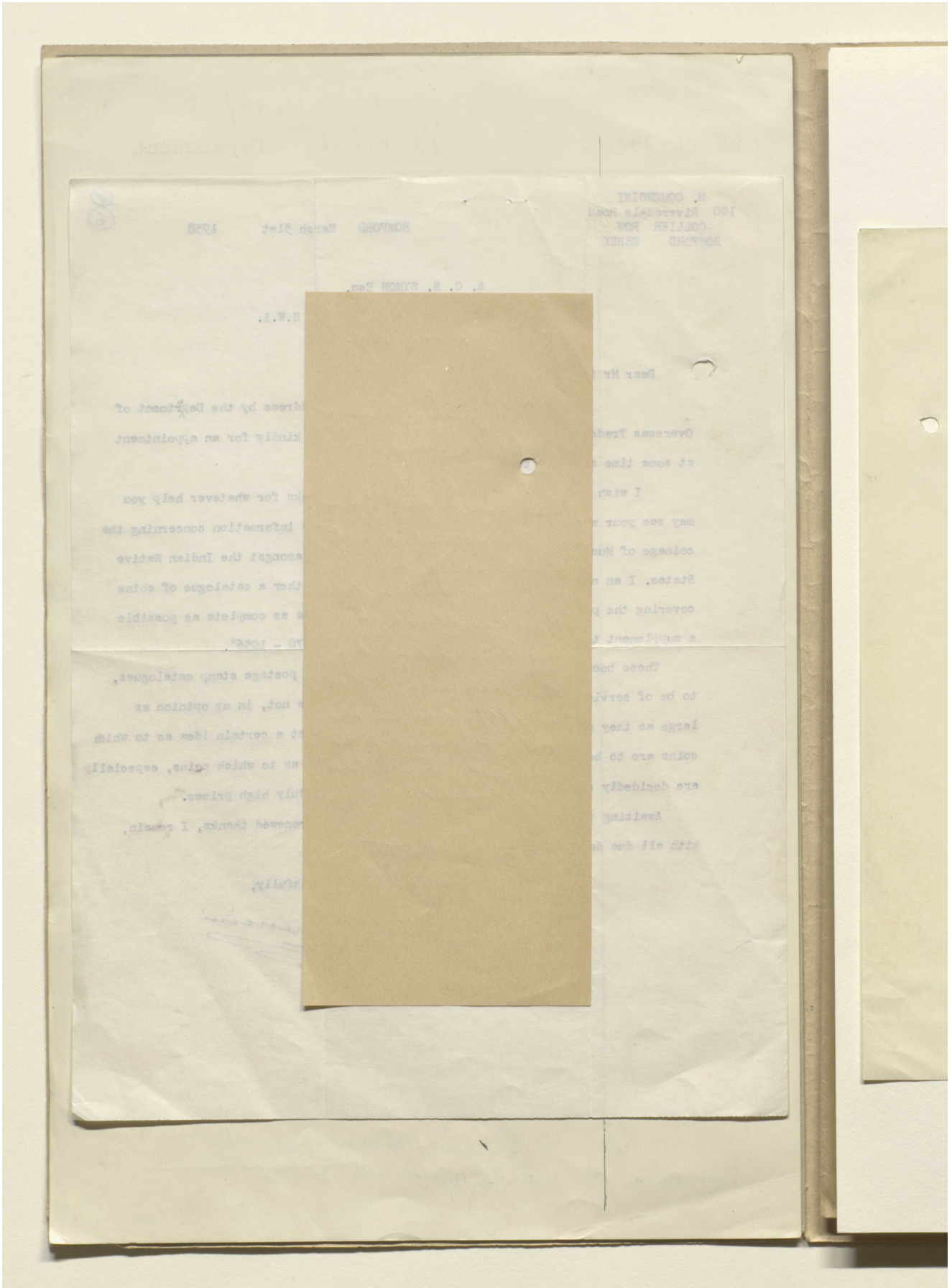

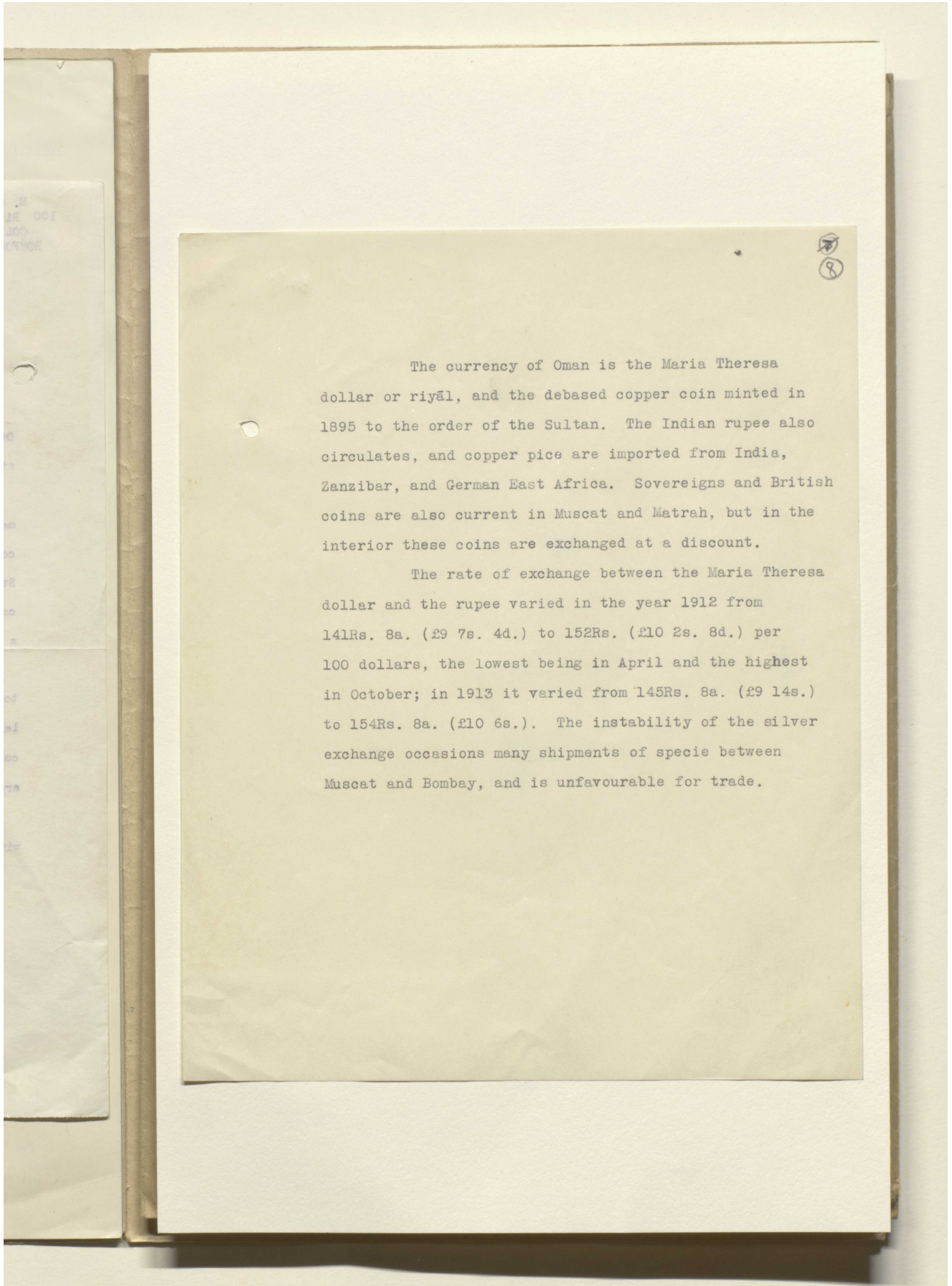
The attached note, which may be of use, is taken from the Handbook to Arabia issued by the Stationery Office in 1919, and is the only reference to the subject which has been found.

NOTES ON THE COINAGE OF MUSCAT & OMAN

PRE - WAR ISSUES: Currency in RUPEES and fractions similar to the currency of India. Is this information correct, please?

Maria Theresia Talers: in circulation, please?

Turkish coins, with or without special marks, in circulation, please?

LOCAL COINAGE: in Rupees and fractions; I have one coin, bronze Quarter Anna with English Inscription as follows: MUSCAT & OMAN FESSULBIN TURKEE IMAM, in centre some Arabic and  $\frac{1}{4}$  ANNA. The Obverse side has a wreath and an Arabic inscription only.

Is it possible to have the dates of the reign of the Imam, please? Also some particulars of the Dynasty, if any, his predecessors and successors, etc. please?

Would it be possible to procure one complete set of coins, or some, please?

In the alternative, could you kindly let me know which values, and the respective metal of the pieces, were forming the set, please?

Would you kindly let me have the correct Official title of the State, please?

Would it be possible to procure one complete set of the coins at present in use, please?

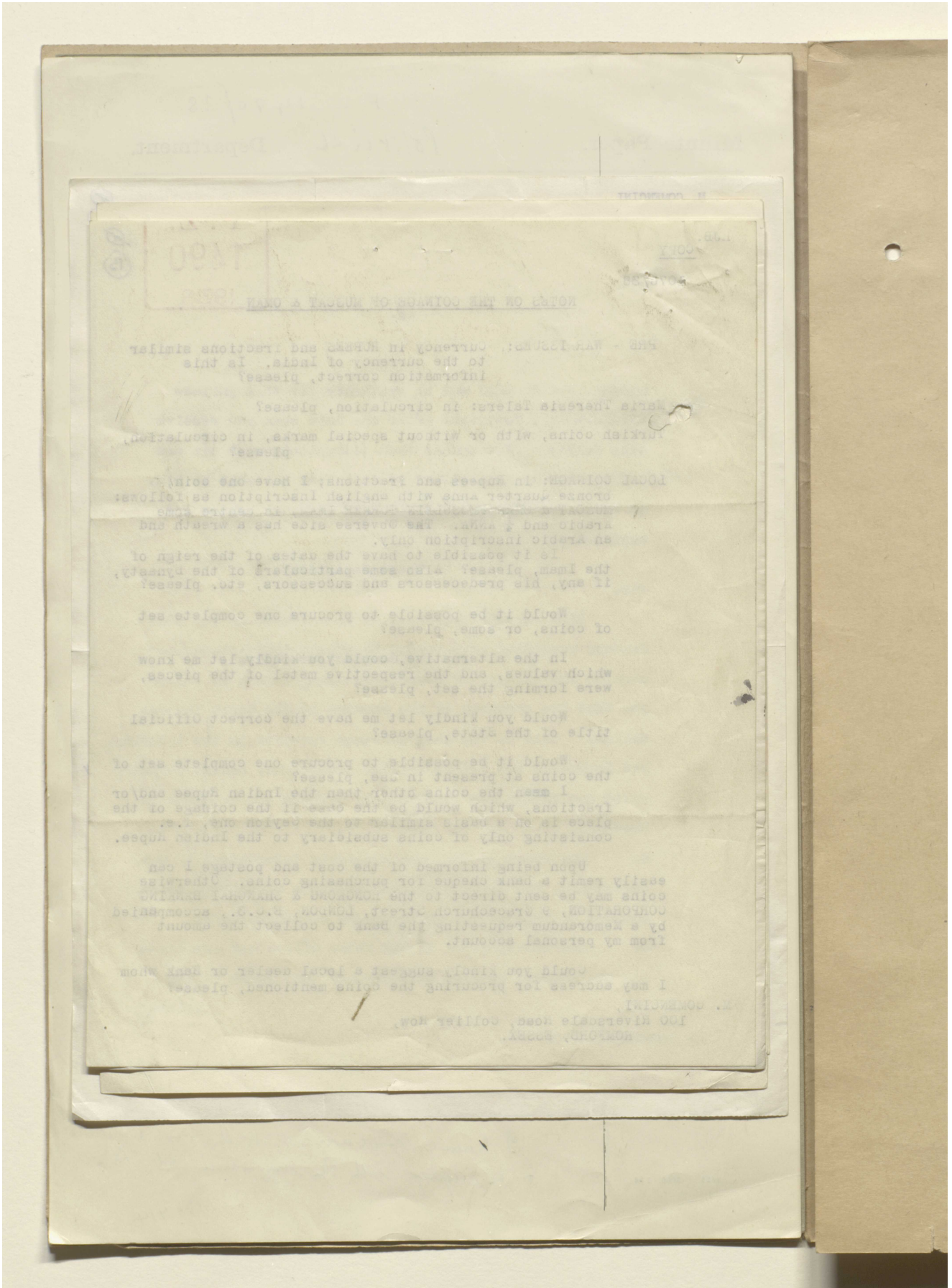
I mean the coins other than the Indian Rupee and/or fractions, which would be the case if the coinage of the place is on a basis similar to the Ceylon one, i.e. consisting only of coins subsidiary to the Indian Rupee.

Upon being informed of the cost and postage I can easily remit a bank cheque for purchasing coins. Otherwise coins may be sent direct to the HONGKONG & SHANGHAI BANKING CORPORATION, 9 Gracechurch Street, LONDON, E.C.3., accompanied by a Memorandum requesting the Bank to collect the amount from my personal account.

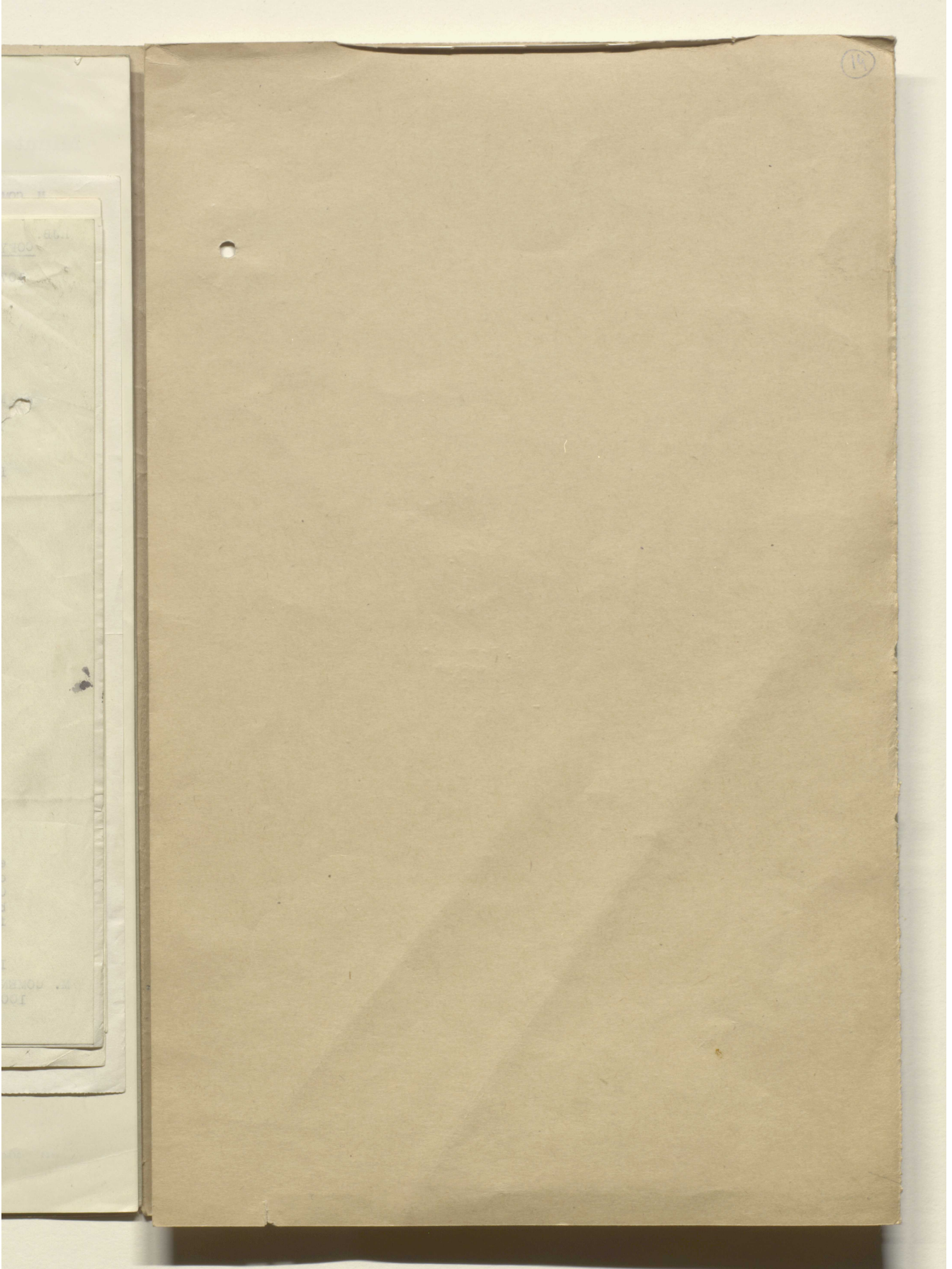
