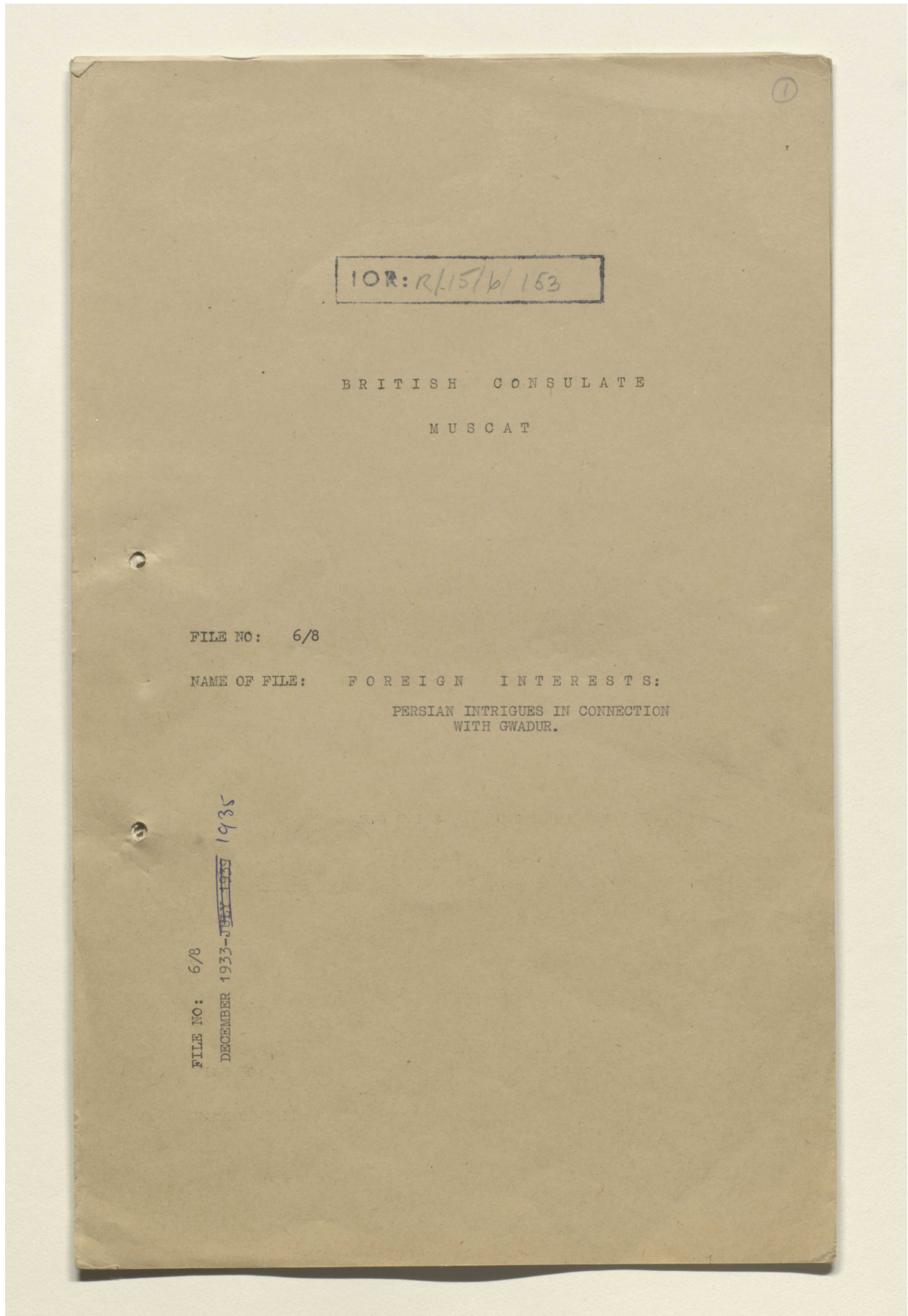

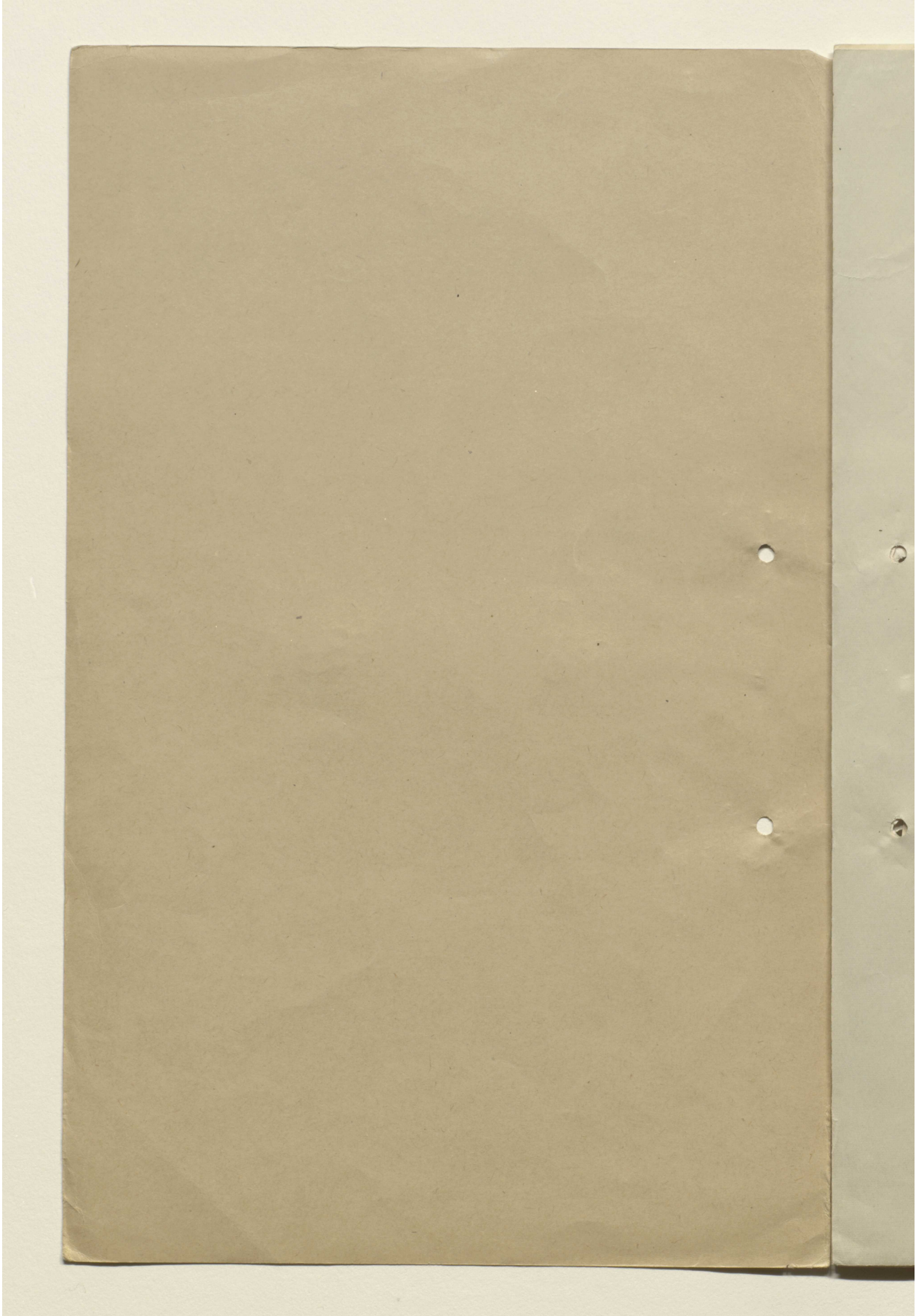
### About this record

This file consists of two letters exchanged between the Political Agency in Muscat and the Political Residency in Bushire regarding allegations that the British Agent at Gwadur had granted Indian visas to Persian subjects with passports not endorsed by the Persian authorities and issued Certificates of Identity to Baluchi-Persian subjects who had claimed British nationality without sufficient evidence.

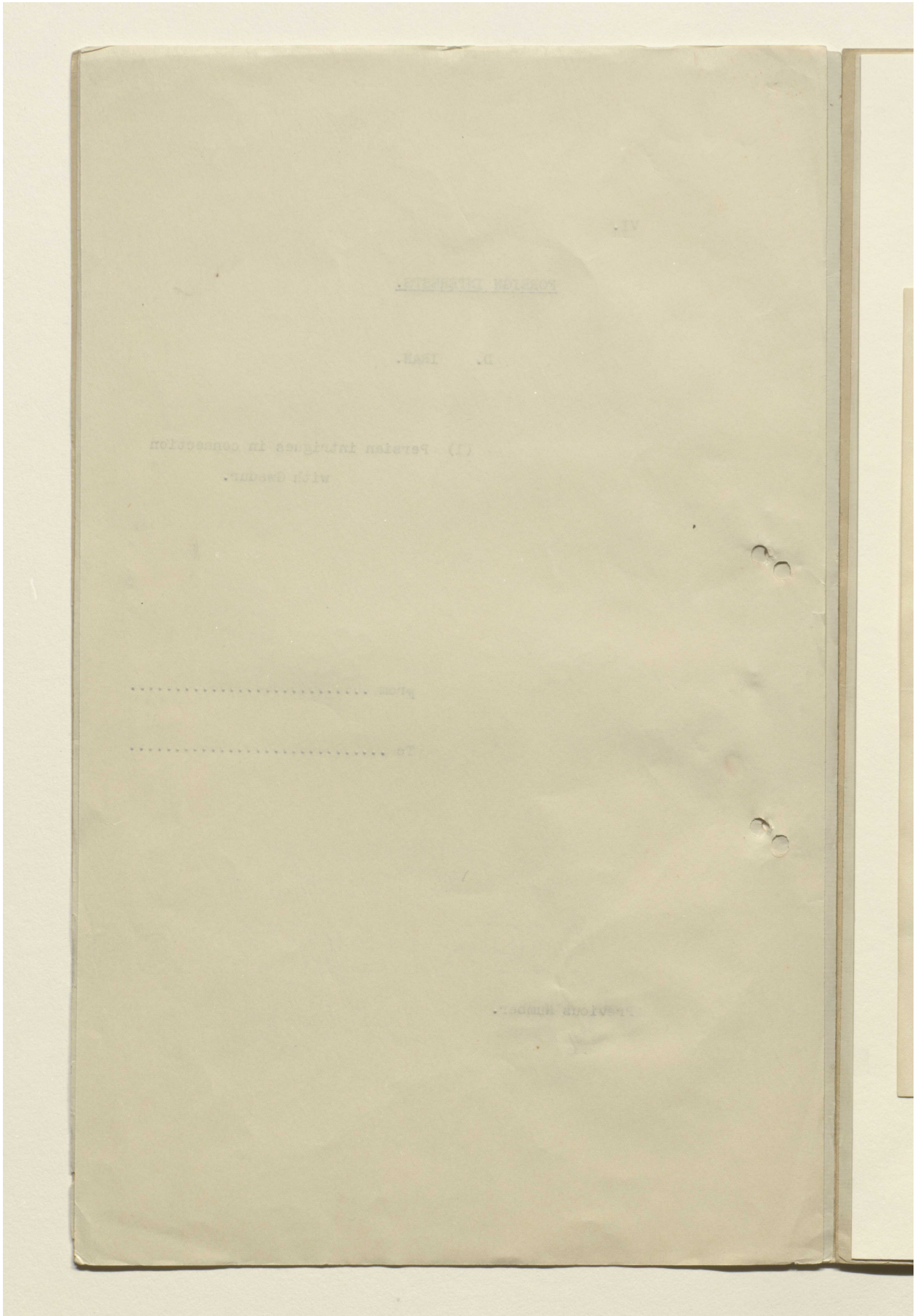

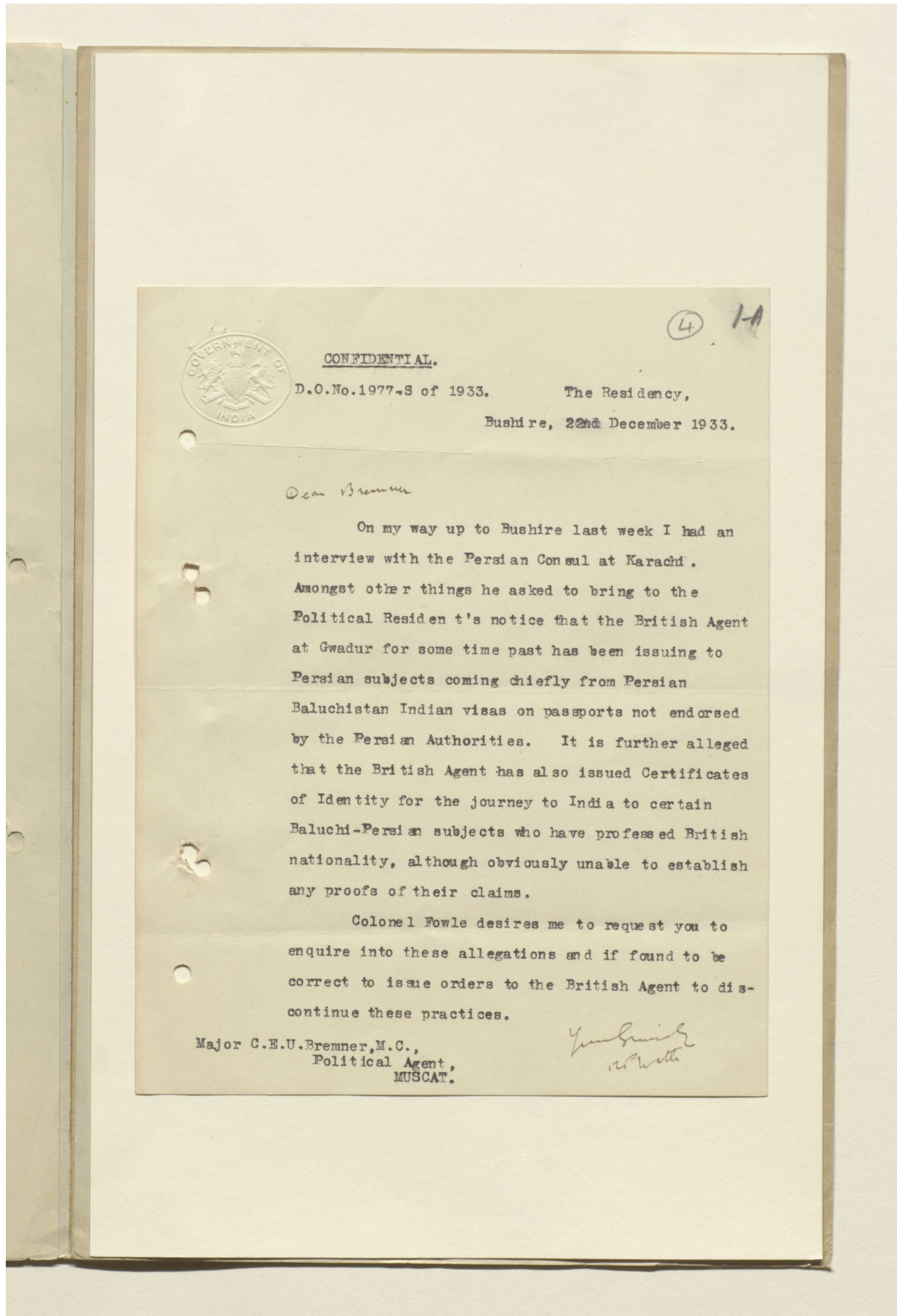

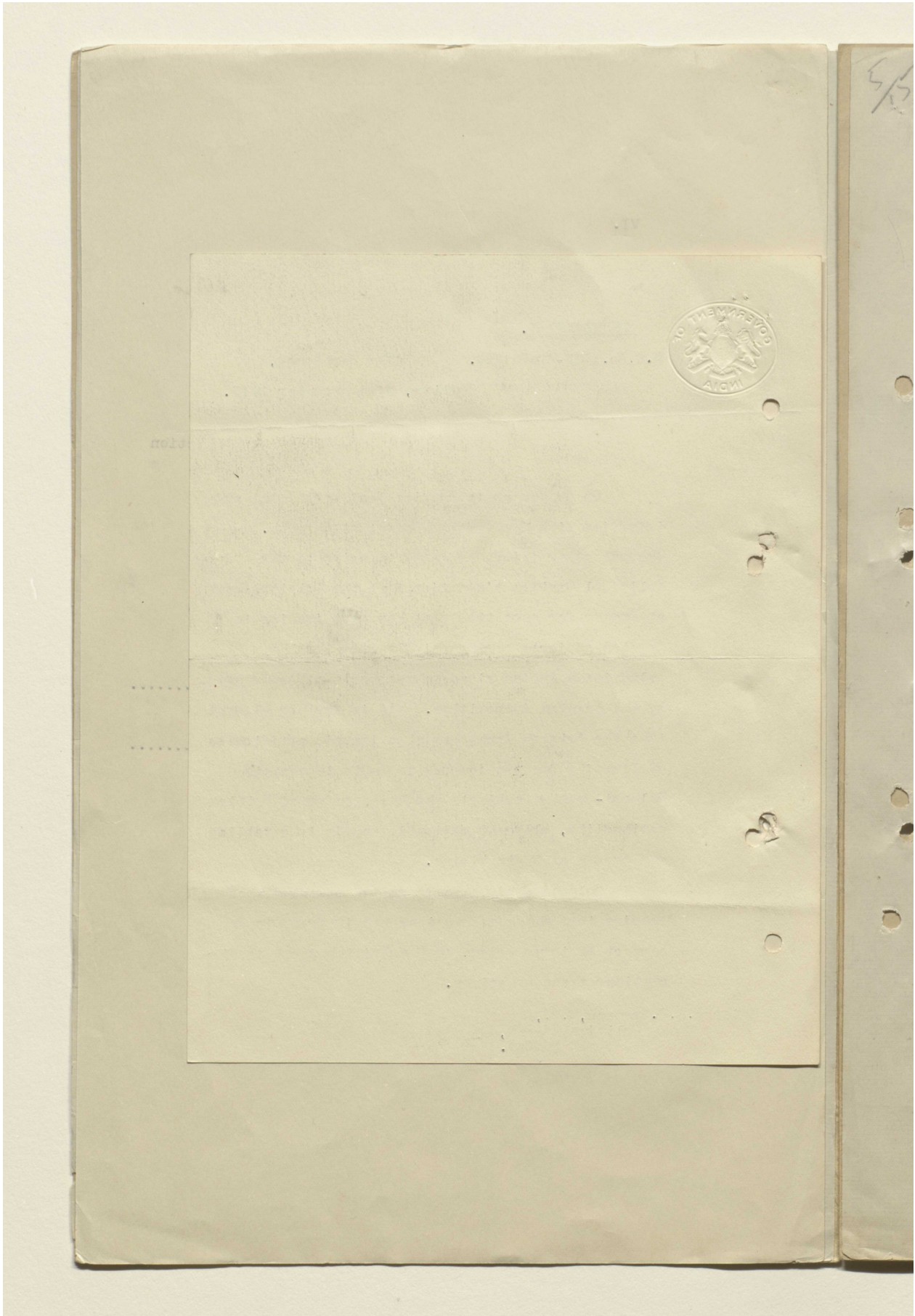

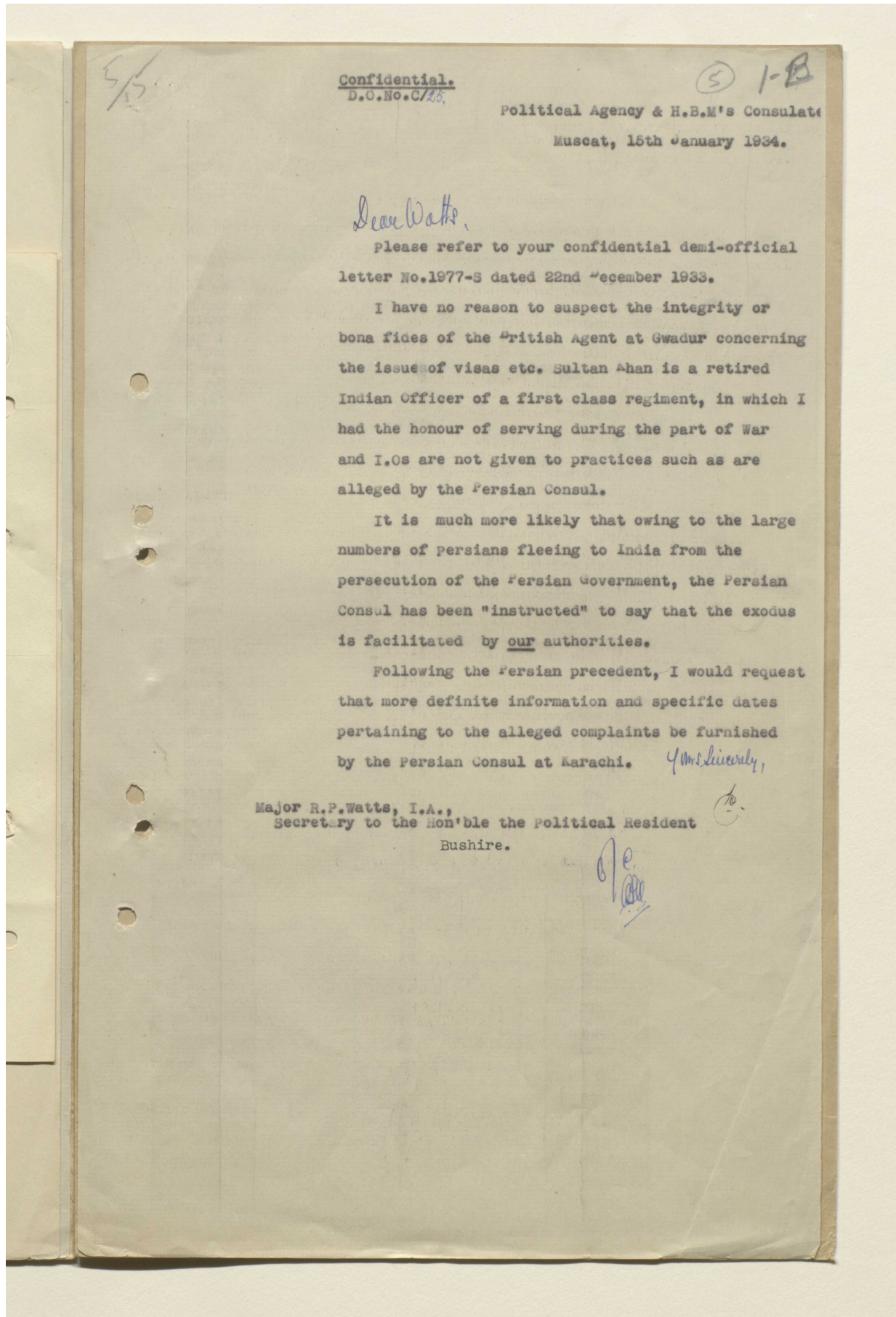

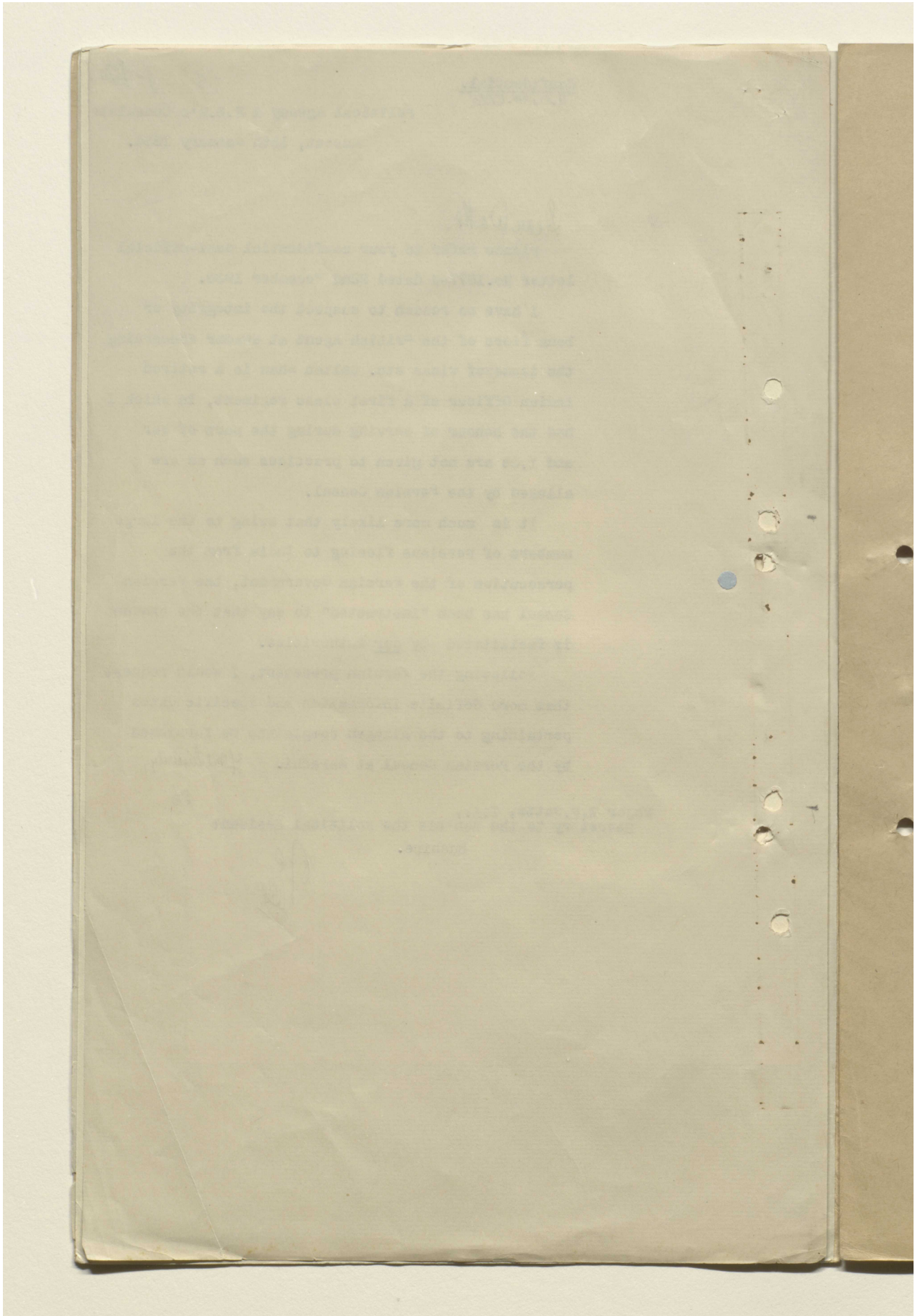
