A copy of a letter from Sir Robert Dundas, President of the Board of Control, to the Chairman and Deputy Chairman of the Court of Directors of the East India Company, dated 4 September 1807. The letter sanctions the payment of £700 to Captain Davies of HMS *Sapphire* to lay in stores in preparation for the departure of Sir Harford Jones as British Envoy Extraordinary to Persia [Iran].



()Whitehall 4 Sept 1807 Gentlemen In the Draft of the Dispatch from the Secret Committee to Sir Harford lones which was sent yesterday to this office, and which has been approved by the Board, it is stated that the sum of £ 100 will be paid to the Captain of this majesty's Ship Sapphire. It having been intimated to me from the Admirally office, that a present advance will be necessary to enable faptain Davies to lay in the necessary Stores for the Vayage, I will be obliged to you to inform me whether it is intended, a whether there is any objection to the payment now of the above Sum of 2 700. to Captain Davies. 


