Copy of a letter from the Resident at Bushire [Būshehr], William Bruce, to HM Minister to Persia [Iran], James Morier, of 4 May 1815. The letter relates to the affair concerning the debts and imprisonment of Mahomed Nebbee Khan [Muḥammad Nabī Khan] (see IOR/L/PS/9/68/181). The letter details the circumstances surrounding the

delay to the release of Khan from imprisonment, and Bruce's difficulties in releasing Khan's assets for the purpose of realising the sum he had paid in advance for his release.

The letter was enclosed in the letter of HM Chargé d'Affaires to Persia, Henry Willock, to HM Secretary of State for Foreign Affairs, Viscount Castlereagh, of 4 December 1818 (see IOR/L/PS/9/68/179), which was received on 29 April 1819.

year I waited on Nizam and Dowlah and auguainted him with the orders I had received from Ser Gove buseley to withhold from his first draft for Jubsidy, such amount as I had a dvanced for the release of mahomed Nelber Shan, until such time as he was liberated and made over to me to enable me to realize the amount I had a dranced for his release. The minister desired me to remain hespectly vatisfied that after his arrival at Thiraz he would send mahomed Nebbee Shan and Family down to me at Bushine and that I might dispose of them in any way I thought proper with this aparance I left Jehran after the return of the minister to Shiraz he acquainted me of the drafts he had on me and requested I would send orders for payment without ever noticing any thing regarding Mohame Nebbe Ahan drawing on one at the same time for considerable sums in Javor of individuals which I accepted and paid and wrote to him in reply that the whole amount of Sir Gore's Bills on me excepting such as had been advanced on account of mahomed Nettre Khan would be discharged immediately, but that-



(2) that this amount would be withheld agreeable to the orders Thad received and had acquainted him with at Jehran ... Several letters papsed between us on this Subject he trying by all the argu ments in his power to induce me to pay the whole amount of the draft but with which I of course refused compliance In the interim I had dispatched Cojea arratoon to Bombay to realize Mahomed Nebber Shand property and come to some settlement with mahomed ale Shan Shushtance the Agent of Mahomed Nelber Athan and in whose hands the latters Ships and property were Cojec arratoon after an absence of Seven months returned without having been able to come to any terms with mahomed Ali Shan. the astensible reason of his failure was that his own claims a gainst that ome hebber Shan were very great and which could only be adjusted by himself, therefore he would not give up any portion of the property in his hopselsion without has claims being regularly admitted by mahomice Notber Shan and which of course could only be done by his being hestectly released. 


