#### About this record

This item consists of copies of correspondence, consultations, and minutes cited in, or enclosed with, political letters from the Government of Bombay [Mumbai]. These political letters appear in IOR/F/4/2203/108134. The correspondents are the Government of Bombay and Major Samuel Hennell, Political Resident in the Persian Gulf. It is the fifth in a series of thirty items.

The item concerns the shooting of Sheik Mahomed ben Yoosoof, Chief of Nukheeloo [Shaikh Muhammad bin Yūsuf, Shaikh of Nakhilu], by Sheik Houssein ben Jabarrah, Chief of Congoon [Shaikh Husayn bin Jubārah, Shaikh of Kangan], and Hennell's intention to consequently make Sheik Houssein liable for the compensation due from Sheik Mahomed to the British on account of seizing money from the agent of a British merchant.

The item contains a contents page, and the title page of the item contains the following references: 'Draft 700/47, Coll[ection]: 18, Collection No 4 of No 37'.






