report for the information of the Honble the  
Governor in Council, that having occasion  
to refer to the 4.<sup>th</sup> Article of the Arabian  
copy of the Treaty entered into with His  
Highness the Imam of Muscat, by  
Captain F. Moresby in 1822, I was surprised  
to find, that no mention whatever was  
made therein touching the obligation of  
His Highness, or his Deputies, to assist in  
the apprehension or seizure of British  
subjects, engaged in the Slave Trade within  
his Territories, as distinctly specified in the  
English Version of the article in question: -

2. On examining the records  
of the Residency in order to elucidate the  
cause of this discrepancy it appeared, that  
the subject had been already brought to  
the notice of Government, in a letter from  
the Persian Secretary, dated the 21<sup>st</sup> September  
1822 No. 57. In the third paragraph of  
his communication, Mr. Simson dis-  
tinctly points out this important omission  
in the 4.<sup>th</sup> Article of the Arabic copy of the  
Treaty: -

tions should be issued to Captain Har-  
merton, the Political Agent at Zanzibar,

His Highness the Imam of Muscat in  
1822, of the obligations of His Highness

hension of British subjects engaged in  
the Slave trade, altho' this is distinctly


