

Dated 28<sup>th</sup> August 1860.

I have the honor to report for  
the information of the Honble the Governor  
in Council that His Highness the Imam  
has been pleased to determine that all vessels  
of every description belonging to His High-  
ness or His Subjects and sailing under his  
flag, shall from henceforth, be provided with  
Registers or Passes - having the number of  
the Pass or Register at the top of the page on  
the left side - and signed by me at the bottom  
of the page on the left side also, <sup>the</sup> writing in  
the body of the Pass or Register will be in the  
Arabic language.

His Highness has adopted  
this regulation to prevent boats trading to  
the Coast of India & other places from using  
His Highness' flag, and thereby falsely decla-  
ring that the vessels are the property of  
His

It is His Highness or his subjects, when they  
are really not so.

I have the honor to enclose a  
Blank register or pass, such as His Highness  
the Imam has adopted for the use of his vessels.

In cases of difficulty, the No. of the  
Register will enable the officers at the vari-  
ous Custom Houses to make a reference  
to any particular book in case of necessity.




