
About this record

This item consists of copies of correspondence, minutes, and consultations cited in, or enclosed with, political letters from the Government of Bombay. The correspondents are the Government of Bombay and the Government of India. It is the fourth in a series of five items.

The item concerns a notification issued by the Government of India on the instructions of the Court of Directors of the East India Company, stipulating that Meerza Mahomed [Mīrzā Muḥammad], who had been dismissed as British Agent in Shiraz, should not be employed by the Company in the future.

The item contains a contents page and the title page of the item contains the following references: 'Draft No 969-1852' and 'Collection No 5 of No 62'.




